

Affiliate Commissions

Earn up to 35%

10% Cash Commissions Paid Monthly +
25% Product Bonus Points Paid Quarterly (subject to eligibility)

35% Total Compensation

Cash Commissions

10% of revenue unless the item is sold with a bonus. When bonuses are given, commission = revenue - 50% of retail price of bonus. For example, a \$1000 sale is made with a \$100 bonus given, the commission will be paid on the \$950 not \$1000.

Paid via Paypal in the first week of the second month after purchase. E.g. a March 15th commission is paid the first week of May.

Commissions only paid when total commission is over \$50. If no sales are referred for one year, commissions under \$50 expire.

Customer payments for sales tax or shipping not included in referral sales totals.

Product Bonus Points

Eligibility

Refer \$1000 or more in sales within three months to be eligible. Once \$1000 is achieved, eligibility is maintained with at least one referred sale within every 6 months with no minimum dollar amount.

Examples:

\$800 in referred sales in 3 months earns the Cash Commission only.

\$1000 or more in referred sales in 3 months earns the Cash Commission AND Product Bonus Points.

Once you are eligible for Product Bonus Points a minimum of one sale every six months is required to remain active.

Point Accrual and Redemption

Receive points equivalent to 25% of dollar amount commission is paid on. For example refer \$1000 in sales and receive 250 points, refer \$10,000 in sales and receive 2500 points.

\$800 in referred sales earns \$80.

\$1000 in referred sales in 3 months or less earns \$100 Cash Commission and 250 Product Bonus Points which are equivalent to \$250 in products at Manufacturer's Suggested Retail Prices (MSRP). Total compensation approximately \$350.

\$10,000 in referred sales earns \$1000 Cash Commission and 2500 Product Bonus Points which are equivalent to \$2500 in products at MSRP. Total Compensation approximately \$3500.

Point Redemption Values

Popular examples:

Refer \$1000 in sales and receive 250 points which is enough to purchase two VitaJuwel Bottles with a retail cost of \$120 each and have 10 points left over.

Refer \$1600 in sales and receive a Cobalt Blue Portable Device (MSRP \$399) from Natural Action Technologies with 1 point left over.

Refer \$3632 in sales and receive a Jivara 3 in 1 (MSRP \$908).

Refer \$10,000 in sales and receive a Jivara Maximus (MSRP \$2499) with 1 point left over.

Point Redemption Shipping Rules

Free shipping for Bonus Point orders assume one domestic destination. If multiple shipping destinations are chosen, Affiliate pays additional shipping costs. Orders shipped internationally are subject to a \$50 shipping charge.

Tier II

Earn 5% Commission on sales referred by an affiliate who you recommend.

This is a selective program and you must be individually approved to participate.

Examples of good Tier II affiliates to refer:

You have a strong relationship with a high profile person or business that is followed by a significant audience. You know them well enough to introduce us and to make sure they listen to our proposal and take action if it is a good fit for them. In this case, you will receive commissions of 5% of the revenue from their customers.

Your business or organization trains others. Good examples of this are an Energy Medicine, Massage, Acupuncture or Nutrition School. The school becomes a Tier II affiliate and recommends our products to their students. The students become affiliates and the school earns a Tier II commission on their sales.
